2022 SCHOLARSHIP PROCESS

1. The **deadline** for returning the completed application and documentation is **Sunday, April 10, 2022.**
2. The required essay, to be written by the parent/guardian applying for the scholarship, must accompany the scholarship application.
3. Proof of the student's Fall 2022 registration/enrollment at a tuition-based private school must be included with the application. This should be a letter, on the school's stationery, signed by the principal, counselor or other school authorized personnel. It must contain the name of the student and grade entering in the fall of 2022.
4. Church membership requirement
 - **K-8 Student Applicants**
Parent of the student **must** be a member of Enon for a minimum of one (1) year as of September 1, 2022. Parent must provide church membership/envelope number.
 - **Grades 9-12 Student Applicants**
Student must be a member of Enon for a minimum of one (1) year as of September 1, 2022. Student must provide church membership/envelope number
5. **The essay must be typed.** Be sure to include the student's name, the parent's name (K-8) and church envelope number at the top of each page of the essay.
6. Submit completed application and required documents to the scholarship ministry:
 - a. **Preferred Method: Use the online scholarship submission on the church website (enontab.org/Resources/Scholarships)**
 - b. **Submit electronically, by midnight on April 10, 2022, to scholarship@enontab.org – on the subject line place “Tuition-Based Scholarship Appl for xxxx xxxxx” (where xxxxxx is the first and last name of the student applicant).**

- **Provide proof of student's enrollment, for grades K-8, at a tuition-based institution for Fall 2022.**
- **Essay (written by the parent) of 100-150 words explaining how this gift award will make a difference to the parent and his/her child, both financially and spiritually. Also include in the essay extra-curricular activities, outside of school, that the student participates in.**

- **Essay (written by the parent) of 100-150 words explaining how this gift award will make a difference to the parent and his/her child, both financially and spiritually. Also include in the essay extra-curricular activities, outside of school, that the student participates in.**

The Quinn Robert Payne Scholarship

- **Provide proof of student's enrollment, for grades K-8, at a tuition-based institution for Fall 2022.**
- **Essay (written by the parent) of 100-150 words explaining how this gift award will make a difference to the parent and his/her child, both financially and spiritually.**

Against The Odds Scholarship

(Sponsored by The Brown Family – Cynthia, Sean & Junine)

This **\$500** non-renewal scholarship is sponsored by the Brown Family. Members of the Brown family attended private schools during their schooling and attribute their academic and career successes to the education received at these schools.

This scholarship is to assist the single-parent, preferably under the age of 26, with the cost for attending a K-8 tuition-based school.

To be considered for this scholarship, you must:

- **Submit a completed application data form**
- **Parent must be an ETBC member for a period of at least one (1) year as of September 1, 2022. Parent's Enon Membership/Envelope Number must be provided.**
- **Provide proof of student's enrollment, for grades K-8, at a tuition-based institution for Fall 2022**
- **Must be a single-parent household; parent preferably under the age of 26.**
- **Essay (written by the parent) of 100-150 words explaining how this gift award will make a difference to the parent and his/her child, both financially and spiritually. Also include in the essay extra-curricular activities, outside of school, that the student participates in and the parent's age.**

Robert A. Payne Memorial Scholarship *(new in 2022)*

Robert A. Payne Memorial Scholarship

(Sponsored by Dr Ellyn Jo Waller and Family)

New in 2022. This **new \$1000** non-renewal scholarship is sponsored by the Waller Family in memory of **Robert A. Payne**, the father of First Lady Ellyn Jo Waller. It is awarded to a male student athlete entering grade 9-12 at a tuition-based school.

The awardee must have a “B” average or higher, display exemplar character, and participate in community service.

To be considered for this scholarship, you must:

- **Submit a completed application data form**
- **Applicant must be an ETBC member for a period of at least one (1) year as of September 1 in the year of the awarding. Student Envelope Number must be provided.**
- **Provide proof of student’s enrollment, for grades 9-12, at a tuition-based institution for Fall of the current year**
- **Provide proof of student’s athletic participation in and/or outside of school**
- **Essay, no more than 300 words. The essay will highlight two personality traits of a book character that they admire and describe how they would like to enact those traits. Book title and author must be included. Also include in the essay community service activities that the student participates in.**
