## **2023 SCHOLARSHIP PROCESS**

1. The **deadline** for completing the online application with required documentation is **Wednesday, April 12, 2023**. Click on link below. First create a student profile. Then select and complete the desired scholarship application.

2. Essay: For the students entering grades K-8 in fall 2023 at a tuition-based school, the application required essay is to be written by the parent/guardian applying for the scholarship. For students entering grades 9-12 in the fall of 2023, the required application essay must be written by the student applicant.
3. Proof of the student's Fall 2023 registration/enrollment at a tuition-based private school must be included with the application. This should be a letter, on the school's stationary, signed by the principal, counselor or other school authorized personnel. It must contain the name of the student and grade entering in the fall of 2023.
4. Church membership requirement
  - **K-8 Student Applicants**  
**Parent** of the student **must** be a member of Enon for a minimum of one (1) year as of September 1, 2023. Parent must provide church membership/envelope number.
  - **Grades 9-12 Student Applicants**  
**Student must** be a member of Enon for a minimum of one (1) year as of September 1, 2023. Student must provide church membership/envelope number

6. Selected applicants only will receive a letter, via postal mail or email, informing them that they have been selected to receive a scholarship. The letter will **NOT** indicate which scholarship the applicant was awarded. Currently the service is scheduled for Saturday, June 10, 2023. The date confirmation and details concerning the 2023 announcement service of scholarship recipients will be included in the notification letter sent to the recipients.

- **Essay (written by the parent) of 100-150 words explaining how this gift award will make a difference to the parent and his/her child, both financially and spiritually. Also include in the essay extra-curricular activities, outside of school, that the student participates in and the parent's age.**

The awardee must have a “B” average or higher, display exemplar character, and participate in community service.

To be considered for this scholarship, you must:

- **Complete the online 2023 Tuition-Based Scholarship application**
- **Male**
- **Applicant must be an ETBC member for a period of at least one (1) year as of September 1 in the year of the awarding. Student Envelope Number must be provided.**
- **Provide proof of student’s enrollment, for grade 9-12, at a tuition-based institution for Fall of the current year**
- **Provide proof of student’s athletic participation in and/or outside of school**
- **Essay, no more than 300 words. The essay will highlight two personality traits of a book character that they admire and describe how they would like to enact those traits. Book title and author must be included. Also include in the essay community service activities that the student participates in.**
